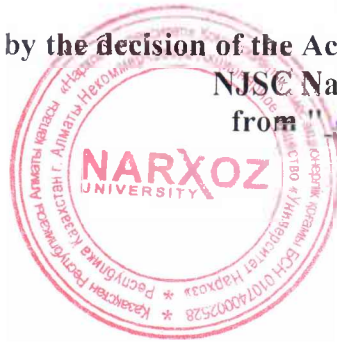

1. GENERAL PROVISIONS

1.1. These Rules for Admission to NJSC Narxoz University for applicants for undergraduate educational programs (hereinafter referred to as the Rules) are developed in accordance with the current regulatory legal acts regulating the activities of educational organizations in the Republic of Kazakhstan, the Model Rules for Admission to Education in Educational Organizations Implementing Educational Programs of Higher Education and postgraduate education, approved by the Order of the Ministry of Science and Higher Education of the Republic of Kazakhstan dated October 31, 2018 No. 600 (hereinafter referred to as the Model Rules), and determine the procedure for admission of applicants for undergraduate educational programs to the Narxoz University Non-Commercial Joint Stock Company (hereinafter referred to as the University) in order to form a student body.

The University accepts persons with a general secondary (general secondary), technical and professional (primary or secondary professional), post-secondary, higher education (higher professional) on the basis of a state educational order and an educational grant of higher education at the expense of the republican budget or local budget, as well as payment for tuition at the expense of the student's own funds and other sources. The process of obtaining and the possibility of participation are regulated in accordance with the current regulatory legal acts.

The right to receive free higher education by foreigners on a competitive basis in accordance with the state educational order is determined by international treaties of the Republic of Kazakhstan.

1.2. Admission to the University is carried out for training:

1.2.1. on an educational grant for higher education programs (based on secondary, technical and professional education);

1.2.2. on a paid basis for higher education programs (based on secondary, technical and professional higher education);

1.2.3. under the educational grant of business partners of the University (on the basis of secondary, technical and professional education).

1.3. Citizens of the Republic of Kazakhstan with technical and professional, post-secondary or higher education are accepted to study under educational programs of higher education, which provide for reduced terms of study.

Admission to the University of persons with technical and professional or post-secondary education with the qualification of "mid-level specialist" or "applied bachelor" in related areas of training of higher education personnel, providing for reduced training periods, entering paid education is carried out by the University Admissions Committee based on the results of the interview.

1.4. Admission to the University of persons with higher education, for a group of educational programs that provide for reduced terms of study on a paid basis, is carried out by the University Admissions Committee based on the results of the interview.

1.5. Admission of persons with technical and professional, post-secondary education (colleges), not to related educational programs, as well as to participate in the competition for the award of a state educational grant, for full or reduced (in the case of a state educational grant) take part in the process of passing the Unified National testing (hereinafter UNT).

The UNT is also held for graduates of organizations of general secondary education (secondary general) of past years, graduates of organizations of technical and professional (primary and secondary professional), post-secondary education, graduates of secondary schools who studied through the international exchange of schoolchildren abroad, as well as persons who graduated from organizations education abroad.

1.6. Admission of persons with higher education to educational programs that provide for reduced terms of study, on a paid basis, is carried out by the University Admissions Committee based on the results of the interview.

Organization of acceptance of documents for participation in the UNT

1.7. Applications for participation in the UNT are accepted by the national testing center.

1.8. The University Admissions Committee provides advice on the deadlines for accepting applications and navigating through the information resources of the National Testing Center.

2. ADMISSION TO THE UNIVERSITY ON THE STATE EDUCATIONAL GRANTS

2.1. Admission to the University for study on an educational grant is carried out on the basis of an application from citizens in accordance with the points of the certificate issued based on the results of the UNT, conducted using technologies developed by the National Testing Center of the Ministry of Science and Higher Education of the Republic of Kazakhstan.

2.2. To the University Admissions Committee or through the web portal of the Electronic Government of the Republic of Kazakhstan egov.kz the following documents are attached:

2.2.1. application for admission to educational programs of higher education for study on an educational grant;

2.2.2. a document on secondary general (general secondary), primary professional (technical and professional), secondary professional (after secondary) or higher education (original);

2.2.3. 6 photographs 3x4 in size;

2.2.4. medical certificate form 075-U (including those issued in electronic format);

2.2.5. UNT certificate (electronic);

2.2.6. electronic certificate of awarding an educational grant;

2.2.7. identity document (copy);

2.2.8. registration certificate (for young men).

2.2.9. certificates confirming the preferential category, if there is a benefit.

Organization of acceptance of documents for participation in the competition for the award of an educational grant of the Ministry of Science and Higher Education of the Republic of Kazakhstan

2.3 The grant is awarded on the basis of a competition for a state grant for the following groups of educational programs, according to Appendix 3.

- Sociology, Psychology, Environment, Information Security, Tourism, Catering and Hospitality, Political Science, Management, Audit and Taxation, Finance, Economics, Banking and Insurance, Marketing and Advertising, Labor Skills, Mathematics and Statistics, Information Technology, Social Work, International Relations and Diplomacy, Law.

2.4. Persons with certificates of international standardized tests SAT, AST, IB with the transfer of points to UNT.

2.5. The application for participation in the competition indicates the selected group of educational programs and the educational organization that implements educational programs of higher education.

2.6. Applications for participation in the competition for the award of educational grants are accepted by the Admission Committee on time in accordance with the rules approved by the Decree of the Government of the Republic of Kazakhstan dated August 25, 2023 No. 443 (or through the e-Government Portal).

2.7. The lists of grant holders are published on the information channels of the NTC and in the mass media within the time limits established by the regulatory legal acts of the Republic of Kazakhstan.

2.8. Citizens of the Republic of Kazakhstan entering the University on the basis of a state grant conclude an agreement on working out for at least 3 (three) years in the manner determined by the Government of the Republic of Kazakhstan.

2.9. Persons who have received an electronic certificate of the award of an educational grant, apply for admission to the University through the e-government portal or offline and are enrolled in the number of students by order of an authorized official of the University by August 25 of the corresponding year.

2.10. Persons who have received an electronic certificate of the award of an educational grant, conclude an agreement for the provision of educational services for an educational grant, a work-out agreement, make a refundable guarantee payment (deposit) in the amount established by the University and provide all necessary documents to the University admissions committee.

2.11. Additional requirements for admission to University educational programs are set out in Chapter 5 of these Rules.

3. ADMISSION TO THE UNIVERSITY ON A PAID BASIS

3.1. Admission of citizens to the University for tuition on a paid basis is carried out according to the applications of citizens on the basis of a minimum threshold score in accordance with the points of the certificate issued according to the results of the UNT, according to Appendix 3.

3.2. With applicants who have scored a threshold score according to the results of the UNT, a Contract is concluded for the provision of paid educational services with the specified cost of the loan under the educational program, as well as the cost of a refundable entrance deposit. After making the payment for tuition and making a deposit in accordance with the terms specified in the Contract, the applicant will be enrolled in the University at the Russian, Kazakh or English department.

3.3. Admission of citizens with general secondary education who have served military service to study at the OHPE on a paid basis is carried out within two years after completing military service based on the results of an interrogation conducted by the admission commissions of the OHPE during the calendar year. At the same time, the enrollment of citizens who have served military service is carried out in accordance with the academic calendar 5 (five) days before the beginning of the next academic period.

3.4. Applicants who have graduated from college have access to abbreviated programs according to Appendix 5, for a period up to August 15. Graduates of the Narkhoz University College of Economics who entered on the basis of basic general secondary education (grades 9) are accepted for a 2-year study program, on the basis of a secondary school (grades 11) they are accepted for a 3-year study program, according to Appendix 5.

3.5. Enrollment among the students of the University is carried out by the Admissions Committee of the University from August 10 to 25.

3.6. Admission of graduates of Nazarbayev Intellectual Schools and/or graduates of the International Baccalaureate (IB), Cambridge A-level programs is carried out in accordance with the Regulation on the Procedure for recognizing the results of formal and non-formal education. Graduates of other schools can apply for the transfer of credits of the discipline "Foreign language", according to the Regulation on the procedure for recognizing the results of formal and non-formal education.

3.7. In the absence of payment on time (the fact of payment is the receipt of funds to the account of the University) - the applicant is not subject to enrollment among the students of the University.

3.8. The applicant has the right to provide a guarantee letter of payment before the start of classes. In case of non-fulfillment of the conditions of the letter of guarantee, the applicant will be expelled from the number of students.

3.9. If a student was enrolled by letter of guarantee or application for deferral, but did not make payment at the time of expulsion at his own request, the student is obliged to pay the amount for the period of study.

3.10. Additional requirements for admission to the University's educational programs are set out in Chapter 5 of these Rules.

4. ADMISSION OF FOREIGN CITIZENS

4.1. Admission of foreign citizens to study at the University on a paid basis is based on the results of an interview conducted by the University Admissions Committee. At the same time, foreign

citizens who graduated from educational organizations on the territory of the Republic of Kazakhstan or abroad enter the paid department of the University based on the results of an interview conducted, including in electronic form.

4.2. The right to receive free higher education by foreigners on a competitive basis in accordance with the state educational order is determined by international treaties of the Republic of Kazakhstan.

Documents submitted in a foreign language must have a notarized translation into the state or Russian language in 2 copies.

4.3. Documents on education issued by foreign educational organizations undergo the nostrification procedure in accordance with the procedure established by the legislation of the Republic of Kazakhstan after enrollment of persons, during the first semester of study.

4.4. The admission process:

- the applicant sends the documents to the email address admission@narxoz.kz to apply for admission;
- the commission for determining the readiness of applicants to study conducts interviews in online/offline format;
- the admission committee sends the applicant a link to the Narxoz English Placement Test to determine the level of English language proficiency (according to Appendix 3 to the Rules);
- the applicant receives the interview protocol and pays 25% of the annual tuition fee of the educational program;
- The Department of Work with Foreign Students and Teachers issues an invitation to study in the Republic of Kazakhstan to obtain a study visa.

4.5. Additional requirements for admission to University educational programs are set out in Chapter 5 of these Rules.

5. ENGLISH LANGUAGE PROFICIENCY REQUIREMENTS

5.1 For admission to the University's educational programs, one of the conditions is to confirm the level of English language proficiency by passing the Narxoz English Placement Test (online or offline).

5.2 Applicants are exempt from taking the Narxoz English Placement Test if they have an IELTS (Academic), TOEFL iBT/CBT, CAE, B2First certificate. At the same time, only those certificates whose validity period is relevant as of August 25, 2024 are accepted for consideration. (inclusive).

6. RESPONSIBILITY OF EMPLOYEES OF THE ADMISSION COMMISSION FOR ADMISSION TO EDUCATIONAL BACHELOR PROGRAMS

Employees of the Admissions Committee are responsible in the event of:

6.1 Failure to comply with the deadlines for receiving documents from applicants.

6.2 Improper performance or failure to perform their duties, within the limits determined by the current labor legislation of the Republic of Kazakhstan, as well as the internal labor regulations of the University.

6.3 Causing material damage within the limits determined by the current labor and civil legislation of the Republic of Kazakhstan.

7. RESPONSIBILITY OF SUBDIVISIONS IN JOINT WORK WITH THE ADMISSION COMMISSION

7.1 The Department of Marketing and Admissions of the University is responsible for the timeliness of the information provided on the official website of the University.

7.2 The Admissions Committee together with the employees of the Center for Information Technologies are responsible for the technical support of the work of the Admissions Committee and the organization of training for technical secretaries and consultants.

7.3 The School of Arts and Social Sciences is responsible for ensuring the smooth running of the Narxoz English Placement Test, in accordance with Appendix 4 to the Rules.

8. UNIVERSITY ADMISSION

8.1 Enrollment in the number of students of the University is carried out by the Admission Committee of the University from August 10 to August 25 of the corresponding year.

8.2 In the case of an applicant applying for an educational loan issued by second-tier banks, the applicant is enrolled in the number of students of the University upon providing them with a relevant certificate from the bank confirming that the documents are under consideration.

At the same time, he is granted a deferment in paying the amount established in the contract for the provision of educational services and payable before it is credited, for the period of obtaining an educational loan, but not more than four weeks from the date of receipt of a certificate from the bank.

8.3 Citizens with a disability of the first or second group, disabled children, as well as disabled since childhood, provide the University Admissions Committee with a conclusion of a medical and social examination (MSE) on the absence of contraindications for studying in the chosen educational program.

9. POLICY AND STRATEGIC OBJECTIVES UNIVERSITY NARXOZ IN THE RECEPTION AREA FOR EDUCATIONAL PROGRAMS OF HIGHER EDUCATION

9.1 The purpose of the recruitment and admission process is to help applicants make the best decisions about their future professional career. This goal takes precedence over other goals, including the achievement of established recruiting goals.

9.2 Applicants should be informed about the University's approach to competencies, the University's standards for learning outcomes, and the methods of verification to achieve such standards.

9.3 The Admissions Committee, in its activities during the Admissions Campaign, brings to the attention of applicants that the University has zero tolerance for cheating in exams, corruption and plagiarism. In particular, applicants should independently familiarize themselves with this information on the University website, the University's social networks.

9.4 The University makes it possible for applicants to contact students who are already studying so that applicants can learn about all aspects of studying at the University through live meetings, creating an information point and infrastructure in social networks, and holding online events. Interference of the University leadership in such meetings is excluded.

9.5 Applicants and their legal representatives can freely ask questions to employees and management of the University. The internal rules of the University oblige the employees of the University to provide applicants with timely, correct and accurate information online / offline.

9.6 The Department of Marketing and Admissions The University on the official website of the University publishes all regulatory documents, quality standards and other internal documents of the University in the field of recruitment of applicants. The University also publishes information about changes in admission procedures in accordance with the current regulatory legal acts of the Republic of Kazakhstan.

9.7 Every year in March of the corresponding year, the Admissions Committee considers complaints and appeals regarding recruiting, selection and enrollment procedures and, if necessary, makes amendments to the work procedure. This performance review includes checking that procedures are aligned with the mission, vision, and strategic goals of the University. The

procedures are annually agreed and approved by the Chairman of the Admissions Committee, no later than April of the corresponding year.

9.8 The Department of Marketing and Admissions and the Admissions Committee provide sufficient information to applicants in order to motivate their transition to the ranks of students of the University. The University ensures that the timing and content of any information or event is appropriate and relevant to the various needs of applicants.

9.9 The admission rules of Narxoz University are based on the principles of respect for the diversity of physical and mental abilities, gender identity, age, socio-economic status, ethnicity, race, nationality, religion and culture of applicants.

9.10 If there are changes in the educational programs of the University, the Marketing and Admissions Department, the Admissions Committee, within its competence, informs applicants about the changes that have taken place and advises them on possible choices in such situations.

NARXOZ ENGLISH PLACEMENT TEST

Narxoz English test is an English language exam that all applicants take to determine their level of English proficiency.

Categories of applicants who pass through the Narxoz English test.
